Making the Reservation

A reservation is held when the front office receives a DEPOSIT and RENTAL AGREEMENT for the date, time, and facility specified per agreement.

Payment Methods

All payments must be made through certified check, cash, (or personal check if at least two weeks prior to event); we do not accept credit cards. All payments must be placed in name of the person named on the Rental Agreement.

Picking up the Keys

Failure to pick up facility keys resulting in Township personnel being sent to allow entrance to the facility will result in a \$25.00 fee, collected by the Township employee that arrives at the event.

Host Liquor Liability Insurance

Any individual (community league member or not), organization or company renting a facility for a private function where alcohol will be served (i.e. a wedding) are required to provide the Township with proof of *host liquor liability insurance* which names McHenry Township and it's Officials as "additionally insured". This insurance can usually be purchased through the company who provides your home owner's insurance. The insurance must be in the name of the person or organization renting the facility.

Refunds

McHenry Township can provide you with a full refund of your deposit as long as you cancel 14 days prior to the event. McHenry Township reserves the right to keep 50% of the deposit in the eventuality that the event is cancelled 7-5 days prior to the event. Also, if the event is cancelled less than 5 days prior to its scheduled date, McHenry Township has the right to refuse a refund on your deposit. Certain exceptions apply such as an unexpected death in the family.
