





**TAX LEVY ORDINANCE**

**MCHENRY TOWNSHIP**

**ORDINANCE 16-1110**

An ordinance levying taxes for all town purposes for McHenry Township, McHenry County, Illinois, for the tax year 2016 collectable in 2017

BE IT ORDAINED by the Board of Trustees of McHenry Township, McHenry County, Illinois, as follows:

SECTION 1: That the sum of One Million Six Hundred Eighty Eight Thousand Seven Hundred and Ninety One Dollars (\$ 1,688,791) are hereby levied upon all property subject to taxation within the Township as that property is assessed and equalized, in order to meet and defray all necessary expenses and liabilities of the Township as required by statute or voted by the people in accordance with the law, for such purposes as:

SECTION 5: That this ordinance shall be in full force and effect after its adoption, as provided by law.
