



TAX LEVY ORDINANCE
MCHENRY TOWNSHIP ROAD & BRIDGE
ORDINANCE RB121318

An ordinance levying taxes for all road purposes for McHenry Township Road & Bridge, McHenry County, Illinois, for the tax year 2018 collectable in 2019.

BE IT ORDAINED by the Board of Trustees of McHenry Township, McHenry County, Illinois, as follows:

SECTION 1: That the sum of Three Million Dollars (\$ 3,000,000) are hereby levied upon all property subject to taxation within the Township as that property is assessed and equalized, in order to meet and defray all necessary expenses and liabilities of the Township as required by statute or voted by the people in accordance with the law, for such purposes as:

PERMANENT HARD ROAD

For the year 2018.

SECTION 2: That the amount levied for each object and purpose shall be as follows:

SECTION 3: That the Town Clerk shall make and file with the County Clerk of said County of McHenry, on or before the last Tuesday of December, a duly certified copy of this ordinance.

SECTION 4: That if any section, subdivision, or sentence of this ordinance shall for any reason be held invalid or to be unconstitutional, such finding shall not affect the validity of the remaining portion of this ordinance.

SECTION 5: That this ordinance shall be in full force and effect after its adoption, as provided by law.
