

TAX LEVY ORDINANCE
MCHENRY TOWNSHIP
ORDINANCE 18-1213

An ordinance levying taxes for all town purposes for McHenry Township, McHenry County, Illinois, for the tax year 2018 collectable in 2019

BE IT ORDAINED by the Board of Trustees of McHenry Township, McHenry County, Illinois, as follows:

SECTION 1: That the sum of **One Million Four Hundred Eighteen Thousand Eight Hundred (\$ 1,418,800)** are hereby levied upon all property subject to taxation within the Township as that property is assessed and equalized, in order to meet and defray all necessary expenses and liabilities of the Township as required by statute or voted by the people in accordance with the law, for such purposes as:
