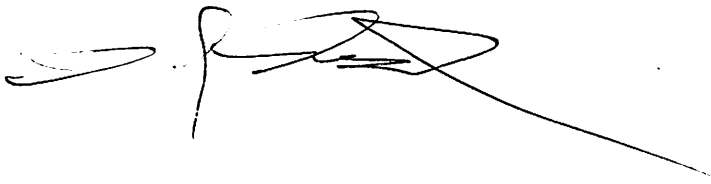
Trustee Macrito thought of having three bids one for the Ballfield, fertilizing and one to cut the grass.
