Road Commissioner Condon offered the Road District's help. Supervisor Barla stated that he was concerned about the ongoing cost of maintaining it. Is the Board willing to put in the budget the money to maintain this project?

Trustee Macrito had a few suggestions on expanding the program Attorney Militello stated that all the suggestions should be addressed and given to the Supervisor. Administrator Macrito added that the Board could bring suggestions at any time to the Supervisor. A very lengthily Discussion ensued between board members and the Attorney

Road Commissioner Condon thanked Trustee Macrito for the kind suggestion but would not recommend that it be adopted in the next election. Supervisor Barla noted that the Board all received a work sheet, it's not complete there are still some holes in it. Supervisor Barla went on looking at our budget is this year and what the salaries were before they were cut in half, if you were to put those salaries on top of our budget what would we have to levy for on top of that and what projects we are going to have to levy for. Supervisor Barla also stated that as Supervisor I do not want to cut into our reserves we are at the rock bottom. Also as Supervisor, I will not put out there any referendum to borrow any money.
