**RESOLUTION # 110724
SETTING COMPENSATION OF TOWNSHIP OFFICIALS
FOR THE FOUR-YEAR TERM STARTING May 17, 2025**

WHEREAS, on June 13, 2024, the Township Board approved Resolution #110724, and the Township Board wishes to amend the Resolution to better clarify compensation.

WHEREAS, according to 60 ILCS 1/65-20, the compensation of township officers shall be set by the township board at least 180 days before the beginning of the terms of office.

WHEREAS, according to 60 ILCS 1/65, the compensation for the road district treasurer shall be fixed by the township board and shall be not less than \$100 or more than 1,000 per year.

WHEREAS, according to 605 ILCS 5/6-207, the compensation of the highway commissioner shall be fixed by the township board at an annual salary of not less than \$3,000 to be paid in equal monthly installments, or per diem amount each day he or she is necessarily employed in the discharge of official duties;

WHEREAS, according to 35 ILCS 200/2-70, the compensation the township assessor and collector shall be set by the township board at the same time the board sets the compensation of its township supervisor.

NOW THEREFORE, BE IT ORDAINED BY the Board of Trustees of McHenry Township that the compensation of the township officials for the four-year term beginning May 17, 2025 and ending May 19, 2029 (January 1, 2026-December 31, 2030 for assessors and collectors) shall be as follows:

SECTION 1: The salaries for township officials shall be as follows:

Supervisor's Salary: Effective starting May 17, 2025-May 19, 2029- **\$102,500.93 Annually**.

Road District Treasurer: **\$1,000.00 Annually**

Township Clerk: Effective starting May 17, 2025 –May 19, 2029- **\$17,500.00 Annually**

Trustees: Effective starting May 17, 2025-May 19, 2029- **\$ 125.00 PER DIEM Annually**


Highway Commissioner: Effective starting May 17, 2025-May 19, 2029 - **\$113,778.32 Annually**

Assessor: Effective Starting January 1, 2026 – December 31, 2030- **\$101,134.47 Annually**

SECTION 2: In addition to the salary outlined in Section 1 above, township officials shall receive the same health insurance, HRA, life insurance, IMRF retirement, and employee paid premiums as all other full time employees.

SECTION 3: For the avoidance of doubt and transparency, township officials shall receive reimbursement benefits in addition to the compensation outlined in Sections 1 and 2 above, for vehicle, phone, clothing/footwear, and other related work expense reimbursements.

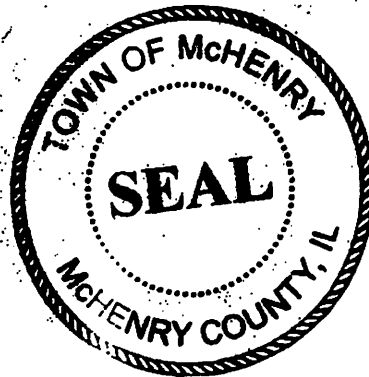
