#1 Sheila Thomas of McHenry

Sheila stated that she had brought her Grandson to the playground and noticed some of the equipment was unsafe. Sheila handed out pictures of the playground and pointed out what she felt was unsafe and was concerned about the safety of the children.

Supervisor Barla pointed out that we are aware of the situation and that we have been working on it, looking at replacing it with a new up to date Playground.

## #2 Robert Beltran of McHenry

He spoke on the community gardens. He asked if it was possible to get a few signs made as to the rules and regulations and suggested cameras.

Supervisor Barla respond that he would talk to Jim about it and put-up signs (please do not pillage our vegetables)

## **#3 Stephanie Tesner of Mchenry**

She spoke about the Gravel Pit being on the agenda tonight and what she thought about the possible negative effect it could have on the environment.

## **#4 Steve Mormino of Mchenry**

He stated that he does not understand how three gravel pits can surround his little subdivision. He said he does not understand how this pit would not affect his neighborhood unincorporated. He worried about the health issue. He went on to say that Mr. Pease does not have a very good reputation.

## #5 Tim Kuraszek of Mchenry

He had a map of the proposed Gravel Pit and the surrounding area he pointed out 470 homes surrounding it within one half mile and a new subdivision adding another 180 homes. He is asked the Mchenry Township to file a formal protest with the County and that would trigger a super majority vote.

Supervisor Barla asked if he had the law that he was referring to, Tim Luraszek answered no but would try to find it and share it with Supervisor Barla.

Supervisor Barla made a Motion to move 8.1 up to the next item second by Trustee Macrito

All ayes Motion carries.

Supervisor Barla turned it over to Trustee Macrito who read a speech he had prepared (the letter is available to the public on request) pointing out three of 10 conditions that would make the passing of the gravel pit fail.

Trustee Macrito pointed out his concerns and that the Township is the smallest form of Government and the closest to the people also that not listening to the Electors as the last board did cost them to be voted out.

Trustee Jaeger stated that he has heard about the concern of truck traffic and that he agrees with Trustee Macrito on this and many other issues on this matter.

Supervisor Barla stated that with the new information brought tonight from Tim that he would like to look at those laws. Kelly Wagner, a county Board member stated that if the Board, Mchenry Township objects that it would force a Super Majority Vote by the County. Discussion ensued.

Trustee Shaver added that Trustee Macrito has done more research than he has, that he agrees with everything that Trustee Macrito, Trustee Jaeger, has said, and that he believes that it is important that we support and represent the people of the Township.

Supervisor Barla stated that he needs to get more information.

Trustee Macrito made a Motion to agree with the City of Mchenry decision against the gravel pit second by Trustee Shaver

Voice vote 4 ayes one abstain.
