**TAX LEVY ORDINANCE
MCHENRY TOWNSHIP**

Ordinance No. 121020

An Ordinance levying taxes for all the township purposes for McHenry Township, McHenry County, Illinois for the tax year 2020, to be collected in 2021.

BE IT ORDAINED by the Board of Trustees of McHenry Township, McHenry County, Illinois, as follows:

Section 1: The sum of Eight Hundred Thousand Dollars (\$800,000.00) are hereby levied upon all property subject to taxation within the Township as that property is assessed and equalized, in order to meet and defray all necessary expenses and liabilities of the Township as required by statute or voted by the people in accordance with the law, for such purposes as:

- a) General Town Fund
- b) General Assistance Fund

For the year fiscal year beginning April 1, 2021 and ending March 31, 2022.

Section 2: That the amount levied for each object and purposes shall be as follows:

Fund No. 001	General Town Fund (Corporate)	\$ 750,000.00
Fund No. 011	General Assistance Fund	\$ 50,000.00
	TOTAL ALL FUNDS LEVIED	\$ 800,000.00

Section 3: That the McHenry Township Clerk shall make and file with the McHenry County Clerk, on or before the last Tuesday of December, a duly certified copy of this Ordinance.


Section 4: That if any sections, subdivision, or sentences of this Ordinance shall for any reason be held invalid or to be unconstitutional, such finding shall not effect the validity of the remaining portion of this Ordinance.


Section 5: That this Ordinance shall be in full force and effect after its adoption, as provided by law.

Adopted this 10th day of December, 2020, pursuant to roll call vote by the Board of Trustees of McHenry Township.


CERTIFICATION OF TAX LEVY ORDINANCE





**TRUTH IN TAXATION CERTIFICATE OF COMPLIANCE
(35 ILCS 200/18-90)**

I, the undersigned, hereby certify that I am the presiding officer of McHenry Township, and as such presiding officer I certify that the levy ordinance, a copy of which is attached, was adopted pursuant to, and in all respects in compliance with the provisions of Section 18-60 through 18-85 of the Truth in Taxation Law.

The taxing district's aggregate levy did not exceed a 5% increase over the prior year's extension. Therefore, a notice and a hearing were not necessary. The provisions of Section of Section 18-60 through 18-85 of the Truth in Taxation Law are **inapplicable** to the 2020 levy ordinance.
