TAX LEVY ORDINANCE
MCHENRY TOWNSHIP ROAD DISTRICT

Ordinance No. 101220

An Ordinance levying taxes for all road purposes for McHenry Township Road District, McHenry County, Illinois for the tax year 2020, to be collected in 2021.

BE IT ORDAINED by the Board of Trustees of McHenry Township, McHenry County, Illinois, as follows:

Section 1: That the Board of Trustees of McHenry Township on this 10th day of December, 2020, does hereby determine and declare that the sum of Two Million Ninety-Five Thousand Dollars (\$2,095,000.00) are hereby levied upon all property subject to taxation within the Road District as that property is assessed and equalized, in order to meet and defray all necessary expenses and liabilities of the Road District as determined by the Highway Commissioner, for such purposes as:

- a) General Road and Bridge
- b) Permanent Hard Road

For the year fiscal year beginning April 1, 2021 and ending March 31, 2022.

Section 2: That the amount levied for each object and purposes shall be as follows:

Fund No. 007	Road and Bridge Fund	\$1,100,000
Fund No. 009	Permanent Hard Road Fund	\$ 995,000
	TOTAL ALL FUNDS LEVIED	\$2,095,000

The Amount to be levied was further agreed to and determined by the Highway Commissioner of McHenry Township Road District.

Section 3: That the McHenry Township Clerk shall make and file with the McHenry County Clerk, on or before the last Tuesday of December, a duly certified copy of this Ordinance.



Section 5: That this Ordinance shall be in full force and effect after its adoption, as provided by law.

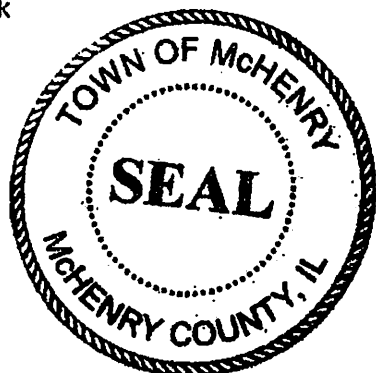





**TRUTH IN TAXATION CERTIFICATE OF COMPLIANCE
MCHENRY TOWNSHIP ROAD DISTRICT
(35 ILCS 200/18-90)**

I, the undersigned, hereby certify that I am the presiding officer of McHenry Township, and as such presiding officer I certify that the levy ordinance, a copy of which is attached, was adopted pursuant to, and in all respects in compliance with the provisions of Section 18-60 through 18-85 of the Truth in Taxation Law.

The taxing district's aggregate levy did not exceed a 5% increase over the prior year's extension. Therefore, a notice and a hearing were not necessary. The provisions of Section of Section 18-60 through 18-85 of the Truth in Taxation Law are **inapplicable** to the 2020 levy ordinance.
