An ordinance levying taxes for all town purposes for McHenry Township, McHenry County, Illinois, for the tax year 2021 collectable in 2022.

BE IT ORDAINED by the Board of Trustees of McHenry Township, McHenry County, Illinois, as follows:

SECTION 1: That the sum of One Million, Five Hundred Fifteen Thousand, Nine Hundred Twenty Seven Dollars (\$1,515,927) are hereby levied upon all property subject to taxation within the Township as that property is assessed and equalized, in order to meet and defray all necessary expenses and liabilities of the Township as required by statute or voted by the people in accordance with the law, for such purposes as:

GENERAL ASSISTANCE

For the fiscal year beginning April 1, 2022, and ending March 31, 2023.

SECTION 2: That the amount levied for each object and purpose shall be as follows:



SECTION 5: That this ordinance shall be in full force and effect after its adoption, as provided by law.



MCHENRY TOWNSHIP
(35 ILCS 200/18-90)**

I, the undersigned, hereby certify that I am the presiding officer of McHenry Township, and as such presiding officer I certify that the levy ordinance, a copy of which is attached, was adopted pursuant to, and in all respects in compliance with the provisions of Section 18-60 through 18-85 of the Truth in Taxation Law.
