TAX LEVY ORDINANCE
MCHENRY TOWNSHIP

Ordinance No. 101024

An Ordinance levying taxes for all town purposes for McHenry Township, McHenry County, Illinois, for the tax year 2024 collectable in 2025.

BE IT ORDAINED by the Board of Trustees of McHenry Township, McHenry County, Illinois, as follows:

SECTION 1: That the Board of Trustees of McHenry Township on this 10th day of October, 2024, does hereby determine and declare that the sum of One Million Seven Hundred Two Thousand, Eight Hundred Eighty One Dollars (\$1,702,881.00) are hereby levied upon all property subject to taxation within the Township as that property is assessed and equalized, in order to meet and defray all necessary expenses and liabilities of the Township as required by statute or voted by the people in accordance with the law, for such purposes as:

GENERAL TOWN FUND - Corporate

GENERAL ASSISTANCE – Public Assistance

For the year 2024.

SECTION 2: That the amount levied for each object and purpose shall be as follows:

Fund No. 001 Corporate Fund	\$1,602,881.00
Fund No. 011 Public Assistance Fund	\$100,000.00
TOTAL ALL FUNDS LEVIED	\$1,702,881.00


SECTION 3: That the Town Clerk shall make and file with the County Clerk of said County of McHenry, on or before the last Tuesday of December, a duly certified copy of this ordinance.

SECTION 4: That if any section, subdivision, or sentence of this ordinance shall for any reason be held invalid or to be unconstitutional, such finding shall not affect the validity of the remaining portion of this ordinance.


SECTION 5: That this Ordinance shall be in full force and effect after its adoption, as provided by law.

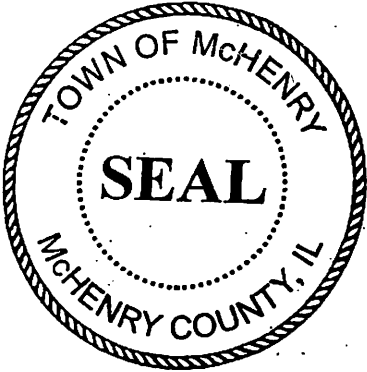

**TRUTH IN TAXATION CERTIFICATE OF COMPLIANCE
MCHENRY TOWNSHIP
(35 ILCS 200/18-90)**

I, the undersigned, hereby certify that I am the presiding officer of McHenry Township, and as such presiding officer I certify that the levy ordinance, a copy of which is attached, was adopted pursuant to, and in all respects in compliance with the provisions of Section 18-60 through 18-85 of the Truth in Taxation Law.

The taxing district's aggregate levy **DID NOT** exceed a 5% increase over the prior year's extension. Therefore, a notice and a hearing **WAS NOT** necessary. The provisions of Section 18-60 through 18-85 of the Truth in Taxation Law **ARE NOT** applicable.
