

**INTERGOVERNMENTAL AGREEMENT  
BETWEEN  
THE COUNTY OF McHENRY AND  
McHENRY TOWNSHIP ROAD DISTRICT  
for**

**Enforcement of McHenry Township Road District's  
ORDINANCE # 98-1**

**“Ordinance of the Highway Commissioner, Town of McHenry, McHenry County Prohibiting  
Parking of Trailers”**

THIS AGREEMENT, is made and entered into this 26th day of May, 1998 between the COUNTY OF McHENRY, a body politic and corporate of the State of Illinois, (hereinafter referred to as the “COUNTY”), the McHENRY COUNTY SHERIFF, (hereinafter referred to as the “SHERIFF”), and the McHENRY TOWNSHIP ROAD DISTRICT a body politic and corporate of the State of Illinois (hereinafter referred to as the “DISTRICT”).

WHEREAS, the DISTRICT has an “Ordinance of the Highway Commissioner, Town of McHenry, McHenry County, Prohibiting Parking”, (hereinafter known as “Ordinance #98-1”) to regulate parking of trailers on roads within the DISTRICT’s jurisdiction; and

WHEREAS, the DISTRICT desires that the SHERIFF enforce the DISTRICT’s “Ordinance #98-1”, and

WHEREAS, the DISTRICT authorizes any and all fine monies resulting from the enforcement of an “Ordinance #98-1” to be paid to the County of McHenry; and

WHEREAS, the SHERIFF desires to assist the DISTRICT enforce its “Ordinance #98-1” in that the enforcement of this Ordinance improves and maintains the health, safety, morals and welfare of the citizens of the COUNTY; and

WHEREAS, the COUNTY and the DISTRICT are authorized by the terms and provisions of 5 ILCS 220/5 et seq., to enter into intergovernmental agreement, ventures and undertakings to perform jointly any governmental purpose or undertaking either of them could do singularly; and

WHEREFORE, the DISTRICT will erect and maintain traffic-control devices and signs to regulate parking in accordance with the DISTRICT’s “Ordinance #98-1”, the laws of the State of Illinois, and the Manual on Uniform Traffic Control Devices USDOT (1988) adopted and amended by IDOT; and

WHEREFORE, the DISTRICT authorizes the SHERIFF to enforce the DISTRICT’s “Ordinance #98-1”; and

WHEREFORE, the SHERIFF will enforce the DISTRICT’s “Ordinance #98-1”, and the SHERIFF has complete discretion as to the enforcement of this “Ordinance”; and

WHEREFORE, it is agreed that the fines collected resulting from enforcement of the “Ordinance #98-1”, will be paid to the COUNTY; and

WHEREFORE, the DISTRICT agrees to indemnify and hold harmless the COUNTY and the SHERIFF, and his deputies, free from liability of any kind resulting from the enforcement of the DISTRICT's "Ordinance #98-1"; and

WHEREFORE, the term of this agreement shall be for a period of one year from the date of the execution by the parties; and

WHEREFORE, it is understood and agreed that the entire agreement of the parties is contained herein and that this Agreement supersedes all oral agreements and negotiations between the parties relating to the subject matter hereof as well as any previous agreements presently in effect between the parties relating to the subject matter hereof; and


WHEREFORE, any alteration, amendments, deletions or waivers of the provisions of this Agreement shall be valid only when expressed in writing and duly signed by the parties.
