

**ORDINANCE OF THE HIGHWAY COMMISSIONER, TOWN OF McHENRY
McHENRY COUNTY, ILLINOIS PROHIBITING PARKING**

Be ordained by the Highway Commissioner of the Town of McHenry, McHenry County, Illinois as follows:

1. Parking is prohibited at all times on any of the following roads as hereinafter described, to wit:

Pleasant View Drive, Bridge Street, Small Street, Circle Drive, Christine Avenue, Louella Avenue, Lucina Avenue, Thelen Drive, John Avenue and Burr Avenue, all located within Pistakee Highlands, McHenry Township, McHenry County, Illinois.

A map delineating the location of each of the aforementioned streets is attached hereto for reference only as Exhibit A.


2. In accordance with Section 5/6-201.16 of the Highway Code of Illinois, as amended, and Section 5/11-304 of the Motor Vehicle Code of Illinois, as amended, a copy of this ordinance, duly certified, will be transmitted to the Superintendent of Highways of McHenry County, Illinois with a request for his written approval of the posting of signs prohibiting parking of vehicles at the places aforementioned upon each of the roads described in Paragraph 1 hereof.

3. Upon receipt of such written approval from the County Superintendent of Highways, which approval will be attached hereto and incorporated as a part hereof as Exhibit B, the aforescribed roads will be posted with signs prohibiting parking, which signs shall each conform to the relevant provisions of the State of Illinois "Manual of Uniform Traffic Control Devices for Streets and Highways"

4. Upon Posting of the signs, as aforementioned, a copy of this ordinance, duly certified, will be transmitted to the Sheriff of McHenry County and the State's Attorney of McHenry County, for enforcement of the terms hereof, pursuant to Section 5/11-304 and 5/11-305 of the Motor Vehicle Code of Illinois, as amended and Sections 5/6-201.16, 5/16-102 and 5/16-105 of the Highway Code of Illinois, as amended.


5. All ordinances or resolutions, or parts thereof, in conflict herewith, are hereby repealed.
6. This ordinance shall be in full force and effect from and after the date of its adoption, subject to the approval of the Superintendent of Highways of McHenry County, Illinois, as aforesaid, which approval shall be appended hereto as Exhibit B as evidence of the authority of posting of signs prohibiting parking at places herein enumerated.
