ORDINANCE NO. 2-85

AN ORDINANCE OF THE HIGHWAY COMMISSIONER,  
TOWNSHIP OF MCHENRY, MCHENRY COUNTY, ILLINOIS,  
ESTABLISHING PARKING REGULATIONS  
ON CERTAIN TOWNSHIP ROADS

---

WHEREAS, the Highway Commissioner has determined that it is necessary for public safety to prohibit the parking of motor vehicles within the corporate limits of said Township for extended periods, and

WHEREAS, the Highway Commissioner has determined that it is necessary for public safety to prohibit the parking of any motor vehicle on certain public streets at a time when snowplows must operate, and

WHEREAS, the Highway Commissioner has determined that large trailers and vehicles may create a nuisance or hazard if left unattended for extended periods, and

WHEREAS, the Highway Commissioner is authorized to maintain and take general charge of the roads of said Township pursuant to Chapter 121, Section 6-201.7 and 201.8 of the Illinois Revised Statutes,

NOW, THEREFORE, BE IT ORDAINED BY THE HIGHWAY COMMISSIONER OF THE TOWN OF MCHENRY, MCHENRY COUNTY, ILLINOIS, AS FOLLOWS:

SECTION I

PARKING LIMITATIONS

Parking of any motor vehicle in excess of 72 hours, or at such times when there is snowfall of 2 inches or more, until such snow is cleared from the roadway, or of any camping trailer or boat and/or boat trailer or other trailer, or motor vehicle in excess of a gross weight of 8,000 pounds for more than 24 hours is prohibited on any McHenry Township road, street or highway. The official definitions of road, street or highway, as contained in Chapter 121, Illinois Revised Statutes, shall apply hereto. McHenry Township roads, streets, or highways, hereinafter known as "Roads", are listed in the McHenry Township "Official List of Roads" as Exhibit A, which is attached hereto and made a part hereof by reference.

A map delineating the location of each of the aforementioned roads is attached hereto for reference only as Exhibit B.

SECTION II

PARKING PROHIBITIONS

Parking is prohibited at all times on any of the Roads listed on Exhibit C, which is attached hereto and made part hereof.

A map delineating the location of each of the aforementioned Roads is attached hereto for reference only as Exhibit D.

SECTION III

PARKING RESTRICTIONS

Parking is prohibited during the times specified, or is restricted as shown for the specific locations listed on Exhibit E, which is attached hereto and made a part hereof.

A map delineating each location limited parking area is attached hereto for reference only as Exhibit F.

SECTION IV

FURTHER APPROVAL

In accordance with Section 6-201.16 of the Highway Code of Illinois, as amended, and Section 11.304 of the Motor Vehicle Code of Illinois, as amended, a copy of this Ordinance, duly certified, will be transmitted to the Superintendent of Highways of McHenry County, Illinois, with a request for his written approval of the posting of signs prohibiting parking of vehicles at the times and places aforementioned upon each of the Roads described in Sections I, II, and III hereof.

SECTION V

POSTING

Upon receipt of such written approval from the County Superintendent of Highways, which approval will be attached hereto and incorporated as a part hereof as Exhibit G, the aforementioned Roads will be posted with signs prohibiting parking during the times aforesaid, which signs shall each conform to the relevant provisions of the State of Illinois' "Manual of Uniform Traffic Control Devices for Streets and Highways."

SECTION VI

ENFORCEMENT

Upon posting of the signs, as aforementioned, a copy of this Ordinance, duly certified, will be transmitted to the Sheriff of McHenry County and the State's Attorney of McHenry County,

for enforcement of the terms hereof, pursuant to Sections 11-304 and 11-305 of the Motor Vehicle Code of Illinois, as amended, and Sections 6-201.16, 16-102 and 16-105 of the Highway Code of Illinois, as amended.

SECTION VII

REPEAL OF CONFLICT

All McHenry Township Ordinances and Resolutions, or parts thereof, in conflict herewith, are hereby repealed to the extent of such conflict.

SECTION VIII

ENACTMENT

This Ordinance shall be in full force and effect from and after the date of its adoption, subject to approval of the Superintendent of Highways of McHenry County, Illinois, as aforesaid, which approval shall be appended hereto as Exhibit G as evidence of the authority for posting of signs prohibiting or regulating parking at the times and places herein described.

Exhibit C

PARKING PROHIBITED AT ALL TIMES

BARNARD MILL ROAD:

- Northeast side of intersection of Ringwood Road.
- Southwest corner of VanBuren, to corner.
- On the bridge, vicinity 7504 west.

CHURCH STREET, in front of St. John's Church.

FOX LAKE ROAD, at southeast side of intersection with U.S. Rte.  
12.

GLENWOOD LANE, from Hillside Lane east along shore line.

HANCOCK DRIVE, at Lake Shore Drive, adjacent to or on the traffic  
island.

HILLSIDE LANE, FROM Glenwood Lane south along shore line.

LINCOLN ROAD, south side from River Road east to Charles Street.

MAY AVENUE, on each side of roadway at the guard rail and creek,  
between signs.

RINGWOOD ROAD, south side at Fox Lake Road.

Exhibit E

PARKING PROHIBITED DURING THE TIMES SPECIFIED,  
OR RESTRICTED AS SHOWN

HANCOCK DRIVE, south side between East Wonder Lake (EWL) Road (north branch) and EWL Road (south branch); trucks over gross weight of 8,000 lbs. between hours of 2:00 A.M. and 6:00 A.M. only.

LAKE SHORE DRIVE, along beach fence at Hancock Drive; no parking between 10:00 P.M. and 6:00 A.M.

PARALLEL PARKING ONLY

BARNARD MILL ROAD, between VanBuren Street and Ringwood Road, each side.

CHURCH STREET, immediately west of intersection of St. John's Avenue.


