

## ORDINANCE

### ORDINANCE OF THE HIGHWAY COMMISSIONER, TOWN OF MCHENRY, MCHENRY COUNTY, ILLINOIS, PROHIBITING OVERNIGHT PARKING.

BE IT ORDAINED by the Highway Commissioner of the Town of McHenry Road District, McHenry County, Illinois, as follows:

1. One hour parking is permitted between the hours of 6:00 a.m. and 2:00 a.m. on the following road; the South half of Hancock Drive from the intersection of Hancock Drive and East Wonder Lake Road.

2. Parking is prohibited at all times between the hours of 2:00 a.m. and 6:00 a.m. or at such other times when there is snow fall of 2 inches or more on the following road; the South half of Hancock Drive from the intersection of Hancock Drive and East Wonder Lake Road.

3. The intersection of McCullom Lake Road and East Wonder Lake Road. A map delineating the location of the aforementioned street is attached hereto for reference only as Exhibit A.

4. In accordance with Section 5/6-201.16 of the Highway Code of Illinois, (Chapter 605 Illinois Compiled Statutes) as amended, and Section 5/11-304 of the Illinois Vehicle Code (Chapter 625 Illinois Compiled Statutes) as amended, a copy of this ordinance, duly certified, will be transmitted to the Superintendent of Highways of McHenry County, Illinois, with a request for his written approval of the posting of signs

restricting or prohibiting parking (as required by this ordinance) of vehicles at the time and places aforementioned upon the road described in paragraphs 1 and 2 hereof.

5. Upon receipt of such written approval from the County Superintendent of Highways, which approval will be attached hereto and incorporated as a part hereof as Exhibit B, the aforescribed road will be posted with signs prohibiting or restricting parking during the times aforesaid, which signs shall each conform to the relevant provisions of the State of Illinois "Manual Of The Uniform Traffic Control Devices For Streets And Highways".

6. Upon posting of the signs, as aforesaid, a copy of this Ordinance, duly certified, will be transmitted to the Sheriff of McHenry County and the State's Attorney of McHenry County, for enforcement of it's terms hereof, pursuant to Section 5/11-304 and 5/11-305 of the Motor Vehicle Code of Illinois (Chapter 625 Illinois Compiled Statutes) as amended and Sections 5/6-201.16, 5/16-102 and 5/16-105 of the Highway Code of Illinois (Chapter 605 Illinois Compiled Statutes) as amended.

7. All ordinance and resolutions or parts thereof in conflict herewith are hereby repealed.

8. This ordinance shall be in full force and effect from and after a date of its adoption, subject to the approval of the Superintendent of Highways of McHenry County, Illinois as aforesaid, which approval shall be appended hereto as Exhibit B as evidence of the authority for posting of the signs prohibiting parking at the times and places herein enumerated.
